ITEM:

Consideration of approving a Purchase Order to Ivey's Construction under their continuing services contract for necessary life-safety improvements to be made to the Northside Warehouse at 400 Dolphin Road in an amount not to exceed \$17,406. (Crowe)

EXPLANATION:

The existing warehouse at 400 Dolphin Road, formerly CT1, on the north side of the Port is an approximately 60,000 SF facility equipped with overhead doors, two (2) dock height loading bays and a fenced secured storage yard to the north.

This facility has been leased for a short term six (6) month period for the storage of bulk paper and/or wood pulp product. Due to the age of the facility and the code requirements enforced at the time it was constructed, certain life-safety items are out of compliance. This purchase order will correct these life-safety items, namely concrete landings, stoops and steps on the outside and inside of emergency egress man doors in addition to the repair of existing and installation of new illuminated interior exit signage.


