EXPLANATION:

The layout modification will improve the visibility of the audience during meetings and will also improve the online streaming of the meetings.

- **Funding Review by Finance (Pat Poston):** The total NTE amount of \$475,786.36 will exceed the budget for this item by \$295,786. However there are funds available in the unused contingency budget. 
