The Canaveral Port Authority (CPA) is seeking qualifications from interested engineering and design firms to provide **CT10 LANDSIDE IMPROVEMENTS DESIGN AND PERMITTING SERVICES** for the Canaveral Port Authority, Cape Canaveral, Florida, RFQ-25-9, PN 25-045. The project requires the design and permitting of landside improvements generally included in the CT10 Feasibility Study. The improvements include a new baggage building, reorganization of intermodal parking areas, and increase areas for baggage laydown, seating and security.

Sealed Qualifications Proposals will be received by the undersigned at Canaveral Port Authority, Maritime Purchasing Center, 399 Challenger Rd, Cape Canaveral, Florida 32920 until **September 17, 2025, at 2:00 PM-EDT (Eastern Daylight Time)**. The Maritime Purchasing Center is open weekdays from 8 AM to Noon and from 1 PM to 5 PM. Also, by the specified date and time, an electronic copy of the Qualifications Proposal must be uploaded through VendorLink.

A selection committee meeting will be held on September 30, 2025, at 2:00 PM for the purpose of reviewing proposals, ranking and possible shortlist selection. On October 8, 2025, the shortlisted firms will participate in oral interviews / presentations (if required), followed by another selection committee meeting at 2:00 PM to prepare the final ranking. The final ranking will be presented to the Canaveral Port Authority Board of Commissioners for approval at their regular October 22, 2025, meeting. The selection committee meeting will be held in the Maritime Purchasing Center, 399 Challenger Rd, Cape Canaveral, FL and will open to the public.

It is anticipated that only one firm will be selected. The Owner reserves the right to reject all proposals with or without cause, to waive technical errors and informalities, and to accept the proposal that best serves the Owner.
